Any male person of good moral character who is a direct descendant of a loyal resident citizen of Texas prior to her merger with the United States of America on February 19, 1846, is eligible for membership in the Sons of the Republic of Texas. Upon application of parent or guardian, a boy under eighteen (18) years of age who is otherwise qualified may be admitted to Junior Membership, automatically to become a full member on his eighteenth birthday. A person who is deceased but otherwise may be admitted to Posthumous Membership.
